## What's going on regarding birth defects

- The second version of the **online atlas for congenital abnormalities** is now available (<u>atlaseclamc.org</u>), curated by the ECLAMC collaboration.
- In a very recent paper from Circulation, Canadian authors reported on significant associations between maternal chronic conditions and congenital heart defects. Many of these conditions, which include diabetes, hypertension, and connective tissue disorders, are also increasing in prevalence, with implications for future rates of heart defects(<a href="http://circ.ahajournals.org/content/early/2013/06/27/CIRCULATIONAHA.112.001054.abstract">http://circ.ahajournals.org/content/early/2013/06/27/CIRCULATIONAHA.112.001054.abstract</a>)
- Authors from the Finnish Register of Congenital Malformations reported on the prevalence of sacrococcygeal teratomas in Finland over a period of 22 years. The paper is available from the Center upon request.
- A recent publication in Ultrasound in Obstetrics and Gynaecology has shown that routine screening for trisomies by cfDNA testing at 10 weeks is feasible also in low risk women, allowing diagnosis of aneuploidies within the first trimester. The study showed that the false positive rate was substantially reduced compared to the combined test, but has also demonstrated the problem of the failure of cfDNA testing in providing results and the need to investigate abnormal results by invasive testing. ## News from the Headquarter and Executive Committee

- The winner of the Alessandra Lisi Memorial Prize 2013 is Tanya Bédard, from the Alberta Congenital Anomalies Surveillance System (ACASS). Tanya's work covers many aspects of the birth defects surveillance, with a special emphasis on coding, classification, and epidemiologic assessment of congenital heart defects. Tanya Bédard will be presented with a plaque during the 2013 Annual Meeting, where she will give a special presentation on her research. Submissions for the 2014 award are welcome.
- We invite you to submit **abstracts for oral and/or poster presentation** at the 40th ICBDSR Annual Meeting. Topics may include, but are not limited to: Causes and mechanisms of birth defects, including modifiable risk factors Genomics and epigenetics of birth defects, and Use of surveillance data in outcomes research and cluster management. - A need for collaborative scientific projects that are undertaken within the ICBDSR has been identified. We invite all member programs to submit concrete proposals for collaborative projects to the center or start a discussion on this topic using the ICBDSR list serv.
- The Executive Committee met at Clearinghouse Headquarter in Rome on June 27 and 28, 2013. The work focused on furthering the financial and legal status of the ICBDSR, membership, scientific and education activities, and the planning of the Annual Meeting. A mid-term report from the Executive Committee will be distributed soon.
- The Ireland-Dublin registry had to discontinue its participation in ICBDSR due to some temporary difficulties. Meanwhile, Dr Bob Mc Donnell has been invited by the Executive Committee, and he accepted, to be an Affiliate Member of ICBDSR.
- Moreover, the application from Dr. Cynthia Colapinto, a graduate of the 2013 Training Program and PhD candidate in population health at the University of Ottawa, to be an Affiliate Member of ICBDSR was accepted by the Executive Committee in the above mentioned meeting, so we welcome her.
