The Canadian Perinatal Surveillance System (CPSS) of the Public Health Agency of Canada (PHAC) announced the release of **Congenital Anomalies in Canada 2013:** A Perinatal Health Surveillance Report. The Report provides a concise overview of six important categories of congenital anomalies in Canada, including Down syndrome, neural tube defects, congenital heart defects, orofacial clefts, limb deficiency defects and gastroschisis. It presents national-level birth prevalence data and temporal trends; provincial and territorial estimates (including maps); and international comparisons. The report also describes methods of primary and secondary prevention, in addition to management and treatment options for selected congenital anomalies.
