## What's going on regarding birth defects

- The inaugural issue of the Birth Defects COUNT partners' newsletter was released in early June. Birth Defects COUNT (Countries and Organizations United for Neural Tube Defects Prevention), CDC's global birth defects prevention initiative, aims to increase folic acid intake among women of reproductive age for the prevention of neural tube defects globally. This first edition of the newsletter features a program highlight focusing on a collaborative initiative between CDC and clinicians and epidemiologists in Kenya, a partner spotlight on the International Federation for Spina Bifida and Hydrocephalus, and other exciting news and events about CDC's global birth defects prevention work. - A promising **article** by Bortolus et al. has just been published in BMC Pregnancy and Childbirth [14(1):166], summarizing a project (a joint effort by research groups in Italy and the Netherlands) to assess the effect of a daily periconceptional dose of 4.0 mg of folic acid, instead of 0.4 mg/day, on reducing the occurrence of all congenital defects, as well as its effects on a series of other outcomes. A total of 1,000 pregnancies need to be evaluated to detect an absolute reduction of the frequency of 8%. The project promotes an international prospective meta-analysis.
