



We had a GREAT World Birth Defects Day Thanks to the 12 promoting organizations and to all the supporters

The total number of unique **Twitter** users that received Tweets with the **#worldbdday** hashtag is 6,165,146, and 544 Accounts (organizations and individuals) joined the **Thunderclap** Campaign via Twitter, Facebook or Tumblr. Together these accounts had a social media reach of over 1.1 Million. At least 34 countries were represented.

Several **ICBDSR members** supported the "Day" through website posts, symposia and meetings, contacts with media, distribution of materials and in many other ways. What's Going on Regarding Birth Defects

The CDC Fetal Alcohol Syndrome Prevention Team at National Center on Birth Defects and Developmental Disabilities shared two new resources on alcohol use during pregnancy from the American College of Nurse-Midwives (ACNM):
