What's Going on Regarding Birth Defects

A cohort study described the prevalence, time of diagnosis, and type of delivery in children and fetuses with urinary tract (UT) anomalies after the introduction of the anomaly scan in the Netherlands in 2007. In the period after the introduction of the anomaly scan, the Authors observed an increasing prevalence of anomalies of the collecting system, but no increase in termination of pregnancies. ESHRE-European Society of Human Reproduction and Embryology will award 2 Research Grants in 2018. Research Grants are designed to support scientists and clinicians (investigators) by funding proposals in basic and clinical research in the field of reproductive medicine. Funding can be used for up to 3 years. Applications for the 50,000 euro Research Grant should focus on the theme "Chromosome and DNA integrity of oocytes and embryos", applications for the 150,000 euro Research Grant on the theme "Maternal determinants of embryo developmental ability".
